Trnava University in Trnava, Faculty of Law, organises the international scientific congress Trnava Days of Law once in two years.

In the spirit of post-positivism and post-modernism, the 21st century is being characterized also as a period of legislative crisis. Instead of legalist reliance on explicit guarantees of legality and formal fairness, the emphasis is being placed on value-laden application and interpretation of law, on legal principles and their balancing. At the same time, however, the importance of legislative law-making is still being neglected. And along with this, the question of how scientific knowledge can contribute to the proper formulation of legal texts – the legal politics – is being set aside.

In recent decades, continental, as well as Anglo-American legal science has focused primarily on the power of the courts, on the question of interpretation of law, on the resolution of hard cases, but it has overlooked the fact that the life of law begins in the legislative process, that the better are laws written, the easier is their application. Legal science was conceived rather as jurisprudence than legisprudence. The quality of law-making, meaning not only of contemporary and current re-codifications, is thereby a precondition for the subsequent correct interpretation and application of law. Legal politics in the sense of drafting legislation (choice of aims and tools) therefore undoubtedly deserves a targeted interest and further elaboration by legal theory and professional practice.

The main topic of the congress is to be further elaborated within individual conferences, sessions, workshops of the international congress, which allows focusing on the specificities of legal policy and law-making in individual branches of law and disciplines of legal scholarship. Each session, conference, workshop of the congress is sponsored by the respective department.
